Pursuant to the request of the City of Morgan Hill ("City"), Karen Kramer of Kramer Workplace Investigations conducted a fact-finding investigation into the complaint made by Council Member Yvonne Martínez Beltrán against Mayor Mark Turner.

## **I. INTRODUCTION**

The City retained Kramer Workplace Investigations on or about February 18, 2025, to investigate Martínez Beltrán's complaint that Turner yelled at her and pushed her on February 7, 2025. Specifically, Martínez Beltrán claims that during a special Council meeting, held on February 7, 2025, Turner approached her, yelled at her, "You're too much," pointed his finger at her, said, "You're going to get in line," and pushed her on her right forearm. Additionally, Martínez Beltrán alleges that Turner retaliated against her for running against him in the November 2024 election. She also indicated during her interview that Turner mistreated her based on her gender and her race.

This report is a fact-finding document created through the methodology described herein. The report contains factual conclusions based upon the information made available during the course of the investigation. It does not draw any legal conclusions or assess whether any City policies or State laws were violated. Furthermore, while several hours were spent interviewing witnesses, this report does not purport to include every detail as described by the individuals involved. Rather, it assesses the important facts as they pertain to the complaint made by Martínez Beltrán against Turner.

## **II. SUMMARY OF FINDINGS**

The allegations against Turner are not sustained. The credible evidence presented fails to establish by a preponderance of the evidence that Turner did not assign Martínez Beltrán to the committees to which she wanted to be assigned because she ran against him in November 2024. Additionally, the preponderance of credible evidence fails to demonstrate that the decision was based on Martínez Beltrán's race and/or gender.

Likewise, the credible evidence presented establishes that more likely than not, Turner did not yell at or push Martínez Beltrán during the special Council meeting held on February 7, 2025. It is undisputed that Turner touched Martínez Beltrán, but the credible evidence presented fails to establish that Turner's contact with her was aggressive or that it was motivated by Martínez Beltrán's gender, race, and/or her running against him in the November 2024 election.

## **III. METHODOLOGY OF THE INVESTIGATION**

The following persons were interviewed as part of this investigation:

1. Council Member/Vice Mayor Yvonne Martínez Beltrán, on April 1, 2025 and April 3, 2025;
2. Christina Turner, City Manager, on April 23, 2025;
3. Council Member Marilyn Librers, on April 29, 2025;
4. Council Member Miriam Vega, on April 29, 2025;
5. Council Member Soraida Iwanaga, on May 1, 2025;
6. Don Larkin, City Attorney, on May 7, 2025; and
7. Council Member/Mayor Mark Turner, on May 13, 2025.

The witnesses were interviewed via Zoom, and their interviews were audio-recorded.<sup>1</sup>

The witnesses were told that they were expected to provide honest and forthright answers to the questions asked. They were also reminded of the City's policy against retaliation and told to not take any retaliatory

action against anyone who participated in this investigation and to report any retaliation directed against them.

The undersigned did not interview all witnesses mentioned in the course of the investigation if, in the assessment of the undersigned, the witness did not have direct, relevant, or significant information related to the specific incidents within the scope of the investigation, or if the undersigned obtained the information from a different credible witness or source.

The following documents were reviewed and relied upon as part of this investigation:<sup>2</sup>

1. Morgan Hill Police Department Incident Report 2502070085-1; and
1. List of City Council Appointments to Outside Agencies (Committee List).

In addition to this document, the undersigned watched a video of the interaction between Martínez Beltrán and Turner that occurred during the February 7, 2025 Council meeting.

#### **IV. DESCRIPTION OF THE ALLEGATIONS – INTERVIEW OF YVONNE MARTÍNEZ BELTRÁN<sup>3</sup>**

Martínez Beltrán had been a Council Member for seven years at the time of her interview and was the Mayor Pro Tem.

Martínez Beltrán advised that she has tried very hard to work with Turner, and she shared that she was successful in doing so for approximately 1½ years. Martínez Beltrán reported that she ran against Turner for Mayor in the November 2024 election, and since that time, he has retaliated against her. She identified her race as Latina and opined that Turner mistreated her because she is not a White woman. Martínez Beltrán opined that Turner has a problem with all women, regardless of their race. She later clarified that she thinks he has a problem with “women who are competent and intelligent.”

##### **A. Committee Assignments**

Martínez Beltrán reported that one of the ways in which Turner retaliated against her was by withholding committee assignments from her. She explained that each year, members of the City Council discuss what committees they are interested in and why they would bring value to their requested committees. Martínez Beltrán opined that Turner stripped her of her duties serving on prestigious committees, knowing that she is trying to build relationships with her colleagues, in an effort to prevent her from being reelected to the City Council.

According to Martínez Beltrán, the Mayor usually attends Cities Association meetings, while the Mayor Pro Tem serves as an alternate.<sup>4</sup> She maintained that for the past 10 years, the Mayor Pro Tem has served as the alternate, and the City has a chart identifying the Mayor Pro Tem as the alternate for the Cities Association. According to Martínez Beltrán, Turner directed City staff to delete the language on the chart identifying the Mayor Pro Tem as the alternate, and he reappointed Council Member Marilyn Librers to the Cities Association as the alternate even though Librers is no longer the Mayor Pro Tem.

Martínez Beltrán opined that Turner did not want her to be a part of the Cities Association because being on that committee would allow her to “get to know” the Mayors and Vice Mayors of neighboring cities. She also assumed that he did not want her to be reelected to the Association of Bay Area Governments (ABAG) Board of Directors, which she explained requires that she have “relationships with a lot of people.”

<sup>3</sup> During her interview, Martínez Beltrán reported several incidents that occurred prior to November 2024, including decisions Turner made during his first term as Mayor. At the direction of the City, incidents that occurred during Turner’s first term as Mayor and during the 2024 election are not included within the scope of this investigation.

<sup>4</sup> Martínez Beltrán described the Cities Association as a “powerful committee” in Santa Clara County, and explained that representatives from all of the cities in the County are part of this committee which makes policy decisions for the County.

Martínez Beltrán reported that a few days after the February 7, 2025 incident, she called Librers to talk to her about the Cities Association Committee. According to Martínez Beltrán, she initially sent Librers a text message, and Librers responded that she was not comfortable talking to Martínez Beltrán in private. Martínez Beltrán shared that she told Librers she understood and asked if they could meet with City Manager Christina Turner (C. Turner) so that a third party was present, but Librers responded that she preferred not to meet with her at all, so she sent Librers an email asking her the questions she had about the committee. She noted that Librers did not respond to her email, but shortly thereafter, C. Turner called her to tell her that Librers received her email and wanted to keep her committee assignments. Martínez Beltrán opined it was odd that Librers did not want to talk to her, and she assumed that Librers felt this way because she was intimidated by Turner.

Martínez Beltrán advised that Turner also removed her from most of her committee assignments. She shared that she was elected to the Valley Transportation Authority (VTA) Policy Advisory Committee and is on the Executive Board for the Silicon Valley Clean Energy (SVCE) Committee, so she remained in those assignments. However, she maintained that she waited for “years” to be assigned to the City/School Liaison Committee, and she noted that she has three school-aged children, which is why she is passionate about that committee. According to Martínez Beltrán, she was part of the committee in 2024, but Turner removed her and assigned Council Member Miriam Vega to the City/School Liaison Committee.<sup>5</sup> Martínez Beltrán noted that Vega is a school teacher in Salinas. She explained that Turner said he was trying to accommodate each Council Member’s requested assignments and to be fair, but she opined it was not fair that she waited for two years to be assigned to the committee, and then Vega was given her assignment.

Martínez Beltrán advised that when Turner first became the Mayor in 2023, she was very interested in joining the Executive Board for the League of California Cities (LCC) Peninsula Division. She explained that the Mayors in the region appoint people to the Executive Board, so she contacted Turner to tell him she had been working with the LCC and would appreciate his support to join the Executive Board to represent Morgan Hill. According to Martínez Beltrán, Turner asked her about the LCC and the Executive Board, so she educated him about both and told him about the committees she had served on for the LCC. Martínez Beltrán advised that Turner told her that he would support her joining the Executive Board. According to Martínez Beltrán, she ran for the Executive Board but was not selected.

Martínez Beltrán reported that the following year, she applied to join the LCC Executive Committee and contacted Turner to ask for his support, but he did not respond to her. She stated that she made several attempts to contact Turner, but he never responded to her until just before the ballots were due, when he told her that he too applied to join the LCC Executive Board. Martínez Beltrán shared that she was selected for the Executive Board, but she pointed out this incident as an example of Turner not being collaborative and being “underhanded.” She noted that the situation was embarrassing for her because she did not know that “her own Mayor” was running against her.

## **B. February 7, 2025 Incident**

Martínez Beltrán explained that the workshop that took place on February 7, 2025, was to “set the stage” for the year and establish expectations. She shared that during the workshop, the departments gave presentations on their projects and priorities. According to Martínez Beltrán, the workshop is a good time for the Council Members to come together to show the departments and the public that they are “on the same page.” She noted that the meeting is less formal than regular Council meetings and that they are set up on the floor instead of on the dais.

Martínez Beltrán explained that during the meeting, the tables were set up like a horseshoe, with Turner seated in the middle and Martínez Beltrán to his left. She noted that next to Turner was C. Turner, and then Librers, who sat next to Martínez Beltrán. According to Martínez Beltrán, to the right of Turner was Vega, then Iwanaga, and then Larkin.

Martínez Beltrán reported that at the end of January 2025, she asked the Mayor to include an item on the City Council meeting agenda regarding the Council issuing a statement saying that the City will protect the rights of all residents regardless of their immigration status. She stated that Turner declined to put the item on the agenda and told her to follow the “full process” to have an item added to the agenda, which she stated would take 1½ months. Martínez Beltrán shared that she spoke to C. Turner about this because it was an urgent issue that needed to be addressed quickly. According to Martínez Beltrán, C. Turner told her that Turner directed that she follow the full process.

Martínez Beltrán advised that she researched the policies and learned that a Council Member can invoke a special meeting or emergency meeting, which she assumed Turner was not aware of because during the February 7, 2025 workshop for goal-setting and to establish the Council's priorities, he refused to allow her to talk about the “immigration policy” because it was not on the agenda. According to Martínez Beltrán, she tried to explain to Turner that the City Council could consider the policy as part of an emergency or special meeting, and that she wanted the City Council to meet the next day for a special meeting. Martínez Beltrán noted that the workshop was originally scheduled for two days, but Turner canceled the second day because, in her opinion, Turner “did not want to listen to four women for one day, let alone two days.”

According to Martínez Beltrán, Turner refused to schedule a special meeting, so she made a motion to schedule the meeting. She stated that she wanted a formal vote on her motion, but Turner never asked for a second to her motion and instead said that he sensed the other Council Members did not want to meet. Martínez Beltrán reported that Turner then called a recess, which was not planned, and cut Martínez Beltrán off as she was talking.

Martínez Beltrán opined that the resolution she wanted put on the agenda was timely because it would protect the rights of all City residents, regardless of immigration status, in reaction to the fear created by the mass deportations.

During her initial interview, Martínez Beltrán explained that when Turner called for a break, she got up to get some food, which was on the other side of the room from where she was sitting, and as she walked behind where Turner was sitting, she saw him shake his head, but she did not recall the first one or two words she said. She reported that Turner yelled at her, “You’re going to get in line,” while pointing with his right hand, so she replied to him, “You’re too much.”

According to Martínez Beltrán, Turner then reached out with his right hand and pushed her on her right forearm. She denied that he pushed her on or near her stomach. Martínez Beltrán reported that she yelled out, “You just pushed me, are you out of your mind? Did you just put your hands on me? What are you thinking? Don’t touch me.” She stated that Turner then turned to her, waved, and said, “Go on, get along.” She noted that he did not deny that he pushed her.

During her second interview, Martínez Beltrán advised that after she got up and walked towards the table where there were drinks, Turner approached her, shook his head, and yelled at her, “You’re too much.” According to Martínez Beltrán, Turner pointed at her like he was talking to a child and said, “You are going to get in line.” Martínez Beltrán advised that she put her hands up, and as she was walking away, Turner “reached out and pushed” her on her arm. She reported that she took a step back and said, “Oh my God, did you just push me? Are you out of your mind? Did you just put your hands on me?” She stated that Turner then said to her, “Go on, get along,” and “shooed” her away.<sup>6</sup>

Martínez Beltrán stated that City Attorney Don Larkin was present when Turner pushed her, and she said to Larkin, “Oh my God, he just pushed me, you saw that? I have to do something.” According to Martínez Beltrán, Larkin responded, “Yes,” and told her that she needed to file a report and talk to Human Resources.

It is unclear if the video Martínez Beltrán watched is the same video provided to the undersigned. During her interview, she noted that the video of the workshop meeting cut off when Turner called for a break because a slide with the agenda stopped the video during the break.

According to Martínez Beltrán, she provided the Police Department with a list of 24 names of witnesses to Turner pushing her.<sup>7</sup> However, she later learned that the Police Department interviewed only C. Turner and Larkin, both of whom she noted can have their positions revoked by the Mayor.<sup>8</sup>

Martínez Beltrán reported that the video she observed showed Turner's elbow move for a split second as he walked towards her. She maintained that she did not walk towards the Mayor, but rather, he walked towards her. She noted there is no audio with the video. Martínez Beltrán maintained that the video clearly shows Turner pursuing her as she walked away from him with her hands up.

Martínez Beltrán noted that when Turner pushed her, everyone except for Librers was standing up. She stated that when she spoke to C. Turner about the incident, C. Turner told her she did not see anything but heard Martínez Beltrán say to Turner, "Don't touch me."

Martínez Beltrán opined that Turner would not have pushed a man or a White woman. She further opined that he has "an issue with race" because he was not willing to "do the immigration resolution" she brought forward and because when there was a Muslim hate crime in the City, Turner did not say or do anything.

According to Martínez Beltrán, Turner was a pastor for 10 to 15 years for a very conservative church. She heard secondhand that Turner "taught obedience" as a pastor. She noted that Turner often paraphrases her to tell her what she means, and that he constantly interrupts her, even when she should be given five minutes of speaking time during Council meetings. Martínez Beltrán reported that Turner muted her on the dais when her time ended, even though she had one more point to make and they were not discussing anything that was controversial.

## **V. WITNESS INTERVIEWS**

### **A. Committee Assignments**

#### **1. City Manager Christina Turner<sup>9</sup>**

C. Turner shared that since the November 2024 election, there had been escalating tension between Turner and Martínez Beltrán. She opined that Turner tries to follow the policies and procedures in place related to the rules and norms for Council Members, but there were occasions when Martínez Beltrán wanted to veer away from the policies, which created tension between them. She also noted that there were occasions when Turner and Martínez Beltrán voted differently on an issue, which may have contributed to the tension.

According to C. Turner, when the Mayor was making committee assignments, Martínez Beltrán wanted to keep some of the committees she was assigned the year prior, but the newer Council Members also wanted to serve on committees, so they requested certain committee assignments. C. Turner noted that she does not play any role in assigning committees to Council Members, and she pointed out that there is a Council policy directing that the Mayor recommend committee assignments, which the City Council ratifies.

C. Turner stated that Martínez Beltrán expressed concerns about her committee assignments, which were an ongoing concern for Martínez Beltrán over the years. According to C. Turner, Martínez Beltrán felt very strongly about having certain committee assignments. However, she noted that Martínez Beltrán did not respond to the email C. Turner sent to all Council Members asking them to identify the committee assignments they wanted and explaining that Turner would then prioritize giving them their requested assignments.

C. Turner reported that after the assignments were disseminated to Council Members, Martínez Beltrán questioned why certain committee assignments she previously held were reassigned to others. She explained that she shared Martínez Beltrán's concerns with Turner, but he stood by his recommendations and did not want to make any changes. According to C. Turner, Martínez Beltrán did not provide her list of requested committee assignments until after the list was disseminated to the Council Members. She did not know why Martínez Beltrán did not respond to C. Turner's initial email.

C. Turner shared that one of the committees that Martínez Beltrán was most upset about was the City/School Liaison Committee. She explained that Vega is a public school teacher and was new to the City Council, so Turner thought it was appropriate for Vega to be placed in this assignment. C. Turner noted that Vega also expressed interest in the assignment.

C. Turner advised that the other committee Martínez Beltrán was upset about was the Cities Association. She reported that Turner is the primary committee member, and the alternate was typically the Mayor Pro Tem, but Turner chose to keep Librers in the assignment to maintain continuity, which C. Turner opined was a valid reason. She noted that every City chooses their primary and alternate members differently and that until 2025, the Mayor Pro Tem was the alternate for the City. According to C. Turner, there is no City policy requiring that the Mayor Pro Tem serve as the alternate for the Cities Association Committee.

C. Turner stated that Martínez Beltrán attended meetings when she was not the appointed committee member and an alternate was not needed.

C. Turner opined that Turner does not have any lingering ill-will towards Martínez Beltrán for running against him for Mayor. She explained that Turner is professional and cordial, and he does not let "campaign stuff" get in the way of carrying on City business.

C. Turner opined that Turner does not have any bias against women or any issue working with women. She noted that Turner is the only male member of the City Council. She further opined that Turner does not have any animus against Martínez Beltrán based on her race. She noted that three of the four female Council Members are Latina. C. Turner stated that Turner never said or did anything that led her to believe he discriminates against females or Latinas.

C. Turner shared that Turner expressed concerns to her regarding interactions he had with Martínez Beltrán, including expressing concerns about the dynamics during City Council meeting, such as Martínez Beltrán taking more than her allotted time to speak, not following processes regarding agenda items, and ignoring other protocols.

## **2. Council Member Marilyn Librers<sup>10</sup>**

Librers reported that as of the date of her interview, she was an alternate for the Cities Association Committee. She did not know if this was a position typically held by the Mayor Pro Tem, and she noted that while she was the Mayor Pro Tem in 2024, she was not a part of the Cities Association Committee.

Librers initially denied having any communication with Martínez Beltrán about her (Librer's) committee assignments. However, she subsequently reported that Martínez Beltrán asked her to forgo her assignment as an alternate for the Cities Association and the LCC so that she (Martínez Beltrán) could serve on these committees. Librers shared that this conversation occurred publicly, during the February 7, 2025 workshop. She did not recall Martínez Beltrán saying why she wanted these particular committee assignments. According to Librers, when Martínez Beltrán asked her to forgo the assignments, Librers said that she was interested in getting involved and would like to keep the assignments. Librers noted that these committees were new to her in 2025, and acknowledged that she did not specifically request these assignments.

Librers shared that Turner spread out the assignments so that the two new Council Members could learn about the different committees. He stated that Turner told the Council Members that he tried to share the committee assignments equally to give the two new Council Members an opportunity to learn.

According to Librers, in prior years, Martínez Beltrán had most of the committee assignments. Librers shared that when she returned to the City Council after a four-year break, she was surprised that she was not assigned to any committees. She opined that it makes sense to spread out the committees.

Librers stated that she had only one interaction with Martínez Beltrán regarding the committees, during the February 7, 2025 workshop. She shared that the only one-on-one communication she had with Martínez Beltrán since the November 2024 election involved the Council Members' travel budget.<sup>11</sup> According to Librers, in the past, Council Members submitted reports for their expenses, but now they are limited to \$3,000 per year. However, she said, Martínez Beltrán always spent more than the other Council Members. She noted that Martínez Beltrán was the only Council Member upset about being given a budget and asked that there be a pool of money that all of the Council Members could pull from, which the other Council Members were against.

Librers reported that Martínez Beltrán was very upset during the meeting in which the travel budget was discussed, so she "called [Librers] out" by asking Librers for whatever money she had left over and did not use. According to Librers, she said, "No," but Martínez Beltrán "was like a dog with a bone" and would not let it go.

Librers explained that she saw Martínez Beltrán at a social event the following Saturday, told her that she was sorry they "went head-to-head," and explained that from her perspective, they have budgets at home they need to live by and budgets at work they need to live by, and she was not willing to give up any of her budgets. According to Librers, Martínez Beltrán was not happy with her, so Librers told her they should try to work together and asked her for a hug, but Martínez Beltrán walked away.

Librers reported that she avoids Martínez Beltrán because she does not like confrontation and because Martínez Beltrán is confrontational when she does not get her way. She opined that Martínez Beltrán was surprised when she (Librers) stood up for herself regarding her committee assignments.

Librers described her professional relationship with Turner as "very good." She does not have any concerns about him being the Mayor and opined that he was doing an "excellent job." She denied that Turner has any issue with women or working with women, and she maintained that he has not mistreated her in any way. She similarly denied that Turner has animus against non-Caucasians, and she noted that the two new female Council Members are Hispanic. Librers maintained that she has not been mistreated by Turner in any way, and she denied that he intimidates her.

Librers stated that Martínez Beltrán publicly accused Turner of retaliating against her regarding the committee assignments because she ran against him for Mayor. She opined that Martínez Beltrán's logic did not make sense, as Turner had no reason to be upset with Martínez Beltrán because she lost.

Librers did not recall telling Martínez Beltrán that she was not comfortable speaking to her privately, but she acknowledged that during the election, when Martínez Beltrán called her many times, she did not return the calls. Librers also did not recall Martínez Beltrán calling her a few days after the February 7, 2025 workshop. However, during her interview, she checked her phone log and confirmed that Martínez Beltrán called her on February 17, 2025. Librers advised that she did not answer or return the call. She acknowledged that she may have asked C. Turner to tell Martínez Beltrán that she was not willing to change her committee assignments.

### 3. Council Member Miriam Vega<sup>12</sup>

Vega advised that she is part of the City/School Liaison Committee, Valley Water Commission, Santa Clara Valley Habitat Agency, and the August Creek Committee, which are the assignments she requested. She noted that the Council Member she replaced served on some of these committees, so she knew there were vacancies, and she requested to be appointed to the City/School Liaison Committee because she is a school teacher.

Vega stated that no one indicated to her that there were any issues with the committees to which she was assigned, but she shared that Martínez Beltrán called her to ask her to consider allowing her to serve on the City/School Liaison Committee. According to Vega, she explained to Martínez Beltrán that she specifically asked to be assigned to that committee because she is a school teacher, and she told Martínez Beltrán that after her first year as a Council Member, if she was not doing what was expected of her on the committee or was doing a bad job, she would allow Martínez Beltrán to “have her spot.” She noted that Martínez Beltrán was not happy with her response, so when Martínez Beltrán called her a second time, Vega did not answer the phone. She reported that Martínez Beltrán asked her about the City/School Liaison Committee on two occasions privately, once publicly during Vega’s first City Council meeting, and on two occasions during the February 7, 2025 workshop. Vega stated that each time Martínez Beltrán asked her to “give” her the City/School Liaison Committee, she responded the same way.

Vega shared that during the February 7, 2025 workshop meeting, Martínez Beltrán was very upset that she was removed from several committees. Vega reiterated that twice that day, Martínez Beltrán asked her to let her “have” the City/School Liaison Committee because she had been waiting for years to be assigned to that committee. According to Vega, Martínez Beltrán told her that she was not assigned to the City/School Liaison Committee “because of retaliation,” but she did not specify for what she was retaliated against. Vega maintained that even though Martínez Beltrán was very upset, she (Vega) did not back down. She noted that initially when she joined the City Council, Martínez Beltrán was assigned to eight committees, while the new Council Members had none until the Mayor asked them to specify the committees in which they were interested.

Vega reported that during the next City Council meeting, when the committee assignments were publicly announced, Martínez Beltrán was still upset. According to Vega, before the meeting started, Martínez Beltrán told her that it was very important to her to participate on the City/School Liaison Committee and that she had waited four years to sit on the committee. Vega shared that Martínez Beltrán also said it was not fair that Vega was assigned the committee during her first year on the City Council. She noted that during the Council meeting after the February 7, 2025 workshop, the City Council voted to approve the committee assignments.

Vega shared that in March 2024, during a luncheon hosted by Gayle Palin, Martínez Beltrán “ambushed” Vega and told her that there was “seniority and ranks” on the City Council and that she should be respectful of the senior Council Members. According to Vega, Martínez Beltrán told her that she was “disappointed” in her, and said that the only reason Vega was elected was because Martínez Beltrán supported her running.

Vega advised that she did not have any difficulty working with Turner. She noted that even though they do not always agree, he did not treat her inappropriately or differently based on her gender. Vega reported that when she ran for election to the City Council, she did not focus on her race but instead focused on being a school teacher and a woman. She noted that even though she and Turner never discussed that she is Hispanic, she believes that he knows she is Hispanic.

Vega stated that she had no reason to believe that Turner has any animus towards Martínez Beltrán based on her race. She shared that during the campaign, Martínez Beltrán told her that Turner is a racist and not to trust him. Vega opined that Turner tried to “lighten the conversation” with Martínez Beltrán and joke with her at times, but whenever Martínez Beltrán addressed Turner, she did so in a sarcastic manner and with

an undertone of dislike. According to Vega, there were occasions during Council meetings when Martínez Beltrán “attacked” Turner by falsely accusing him of saying or doing something that Vega knew he did not do or say. She noted that during the LCC conference, when she went to a dinner with Martínez Beltrán and Turner, Martínez Beltrán sat next to Turner with her back to him the whole time and rolled her eyes. She opined that Turner is respectful towards Martínez Beltrán, but his respect is not reciprocated.

#### **4. Council Member Soraida Iwanaga<sup>13</sup>**

Iwanaga advised that she is a member of the Sister Cities, Santa Clara Water, and Waste Management committees. She noted that C. Turner sent her an email shortly after she was elected to the City Council asking her to create a list of committees she was interested in joining. She stated that she is a nurse and that working with youth appealed to her.

According to Iwanaga, she told C. Turner that she was interested in whatever committee she was needed because she did not know very much about any of the committees or which ones would be interesting to her. She stated that she expressed interest in any committee involving commuting because she commutes long hours, but she was not appointed to anything related to commuting. Iwanaga noted that it made sense to her that Vega was assigned to a committee involving youth because Vega is a school teacher.

Iwanaga pointed out that she is assigned to the least number of committees.

Iwanaga advised that she has not been mistreated by Turner, nor has she observed him engage in any behavior that she thought was inappropriate or unprofessional. Iwanaga stated that she does not have any reason to believe that Turner has animus towards females or Hispanic women.

#### **5. City Attorney Don Larkin<sup>14</sup>**

Larkin reported that he attends most City Council meetings, including special meetings. He stated that on the rare occasion that he does not attend a Council meeting, the Assistant City Attorney attends on his behalf.

Larkin did not recall having any one-on-one communications with Martínez Beltrán about her committee assignments prior to February 7, 2025, but he heard thirdhand during a meeting with Turner, C. Turner, and the City Clerk that Martínez Beltrán was not happy with her assignments. Larkin assumed that C. Turner or the City Clerk mentioned the committee assignments to notify Turner that Martínez Beltrán was unhappy.

According to Larkin, during this meeting, Turner explained some of his reasons for making the changes to the assignments he recommended. For example, Larkin stated, Turner said that because he is on the board for the Peninsula LCC committee, he wanted someone else to have an opportunity to get involved on the committee. He did not recall Turner’s explanations for other committee assignments but noted that they seemed reasonable to him at the time.

Larkin reported that the committee assignments have to be formally adopted by the City Council and that during the special meeting on February 7, 2025, everyone except Martínez Beltrán was happy with the assignments. According to Larkin, Vega spoke up and said that if Martínez Beltrán had her way, she (Vega) would have no committee assignments because Martínez Beltrán wanted to be assigned to all the committees. Larkin noted that following that interaction, Martínez Beltrán did not seem fully engaged and left the meeting shortly thereafter.

According to Larkin, during the next Council meeting, Martínez Beltrán was still upset about not being assigned as the alternate for the Cities Association Committee, which typically is assigned to the Mayor Pro Tem. Larkin shared that Turner said it was “not a hard-and-fast rule” requiring the Mayor Pro Tem to

be the alternate. According to Larkin, this upset Martínez Beltrán because there used to be a note on the committee assignment list that indicated the alternate for the Cities Association is the Mayor Pro Tem, but the note was deleted on the final version of the assignment list. Larkin opined that Martínez Beltrán was upset because she did not get her way.

Larkin denied having any knowledge of Turner having difficult interactions with women in general. He reported that there are a lot of women in leadership positions within the City. He stated that he never observed Turner having a difficult interaction with any female employee, but he noted that he saw Turner get frustrated with both men and women and not always act in a positive manner.

Larkin advised that prior to the November 2024 election, Martínez Beltrán was the only Latina on the City Council, but during the November 2024 election, two Latinas were elected to the City Council. He opined that Turner's actions with Vega and Iwanaga were professional. He had no knowledge of Turner having any animus to females or Latinas.

## **6. Council Member/Mayor Mark Turner<sup>15</sup>**

Turner advised that when he was elected Mayor in November 2022, Martínez Beltrán was a member of the City Council. He did not serve on the Council prior to being elected Mayor.

Turner stated that he recommended Martínez Beltrán to be the Mayor Pro Tem, with the rest of the Council approving his appointment. He stated that he could have kept Libers in the Mayor Pro Tem position, but he noted that the assignment is typically for one year, so it made sense for him to recommend Martínez Beltrán. Turner shared that the other two Council Members were brand new to the Council, so they would probably not understand their role if they had to fill in for Turner.

Turner advised that after the November 2024 election, the conflicts between him and Martínez Beltrán were consistent with what they were in the past, in that Martínez Beltrán was abrupt with him, "somewhat insulting," and aggressive in tone.

According to Turner, Martínez Beltrán was disruptive and dismissive with his predecessor. He noted that she does not follow the protocols, rules, and regulations governing the City Council. For example, Turner stated, Martínez Beltrán disregards the time limit to speak placed upon each Council Member. He shared that although his predecessor did not enforce this Council norm, he campaigned on running efficient Council meetings, so when Martínez Beltrán exceeded her time limit, he interrupted her to move on. He stated that Martínez Beltrán objected to Turner stopping her and that they spent several minutes arguing about the rules all Council Members are expected to abide by because she "does not like being told no."

Turner shared that when he stopped Martínez Beltrán from speaking or belaboring a point, she made "little insults," which he opined were intended to draw him into an argument. He stated that he apologized to her on one occasion after she cast her vote incorrectly and asked to correct it, but he said they were "not going back." According to Turner, he thought about his decision a bit more and decided he did not handle the situation appropriately, so he apologized to Martínez Beltrán after the meeting and told her that next time she made a mistake voting, he would allow her to recast her vote.

Turner advised that in 2023, while they were reviewing the budget, C. Turner pointed out to him that most of the Council Members spend approximately \$3,000 or less for travel expenses, but Martínez Beltrán spent approximately \$8,000. He noted there was no specific budget limiting the amount of travel expenses at the time, so there was some discussion among the Council Members about setting a limit for each Council Member, and former Council Member Renee Spring recommended the limit be \$3,000.

According to Turner, Spring said that if he did not use his full \$3,000 budget, he would give the remainder to Martínez Beltrán for her to use, but the Council agreed that was not an acceptable use of a Council

Member's travel budget. Turner reported that Martínez Beltrán verbally assaulted every Council Member who agreed with the \$3,000 limit, which was approved by the 2024 City Council.

Turner stated that he recommends committee assignments to the City Council, which votes on his recommendations. According to Turner, he worked with C. Turner to have the Council Members review the various committees and let them know if they had any preferred assignments. He noted that everyone responded to C. Turner's request by the due date except for Martínez Beltrán.

Turner advised that Martínez Beltrán did not notify him or C. Turner of her preferred assignments until after he included his recommendations as part of the agenda packet for the February 7, 2025 meeting.<sup>16</sup> He explained that after the agenda was published, C. Turner notified him that Martínez Beltrán was upset that she did not keep all of the assignments she had the prior year. He shared that he did not have any communication with Martínez Beltrán about the committee assignments, but rather, Martínez Beltrán expressed her displeasure with the assignments to C. Turner.

Turner stated that dividing the committee assignments was more challenging than he anticipated. He explained that there were two new Council Members who wanted to be involved in committees. Turner shared that he removed Martínez Beltrán from two or three of the committees she previously served on to ensure the new Council Members had committee assignments.

Turner advised that he recommended Vega for the City/School Liaison Committee because Vega is a school teacher, so it made sense for her to be a part of this group. He noted that he left Librers as the alternate for the Cities Association because he wanted there to be continuity on the committee. According to Turner, there is no rule requiring the Mayor Pro Tem be assigned to the Cities Association Committee. Turner reported that Martínez Beltrán remained in her LCC assignments and remained a part of the VTA Advisory Board.

Turner explained that the Mayor is assigned to the VTA Board and that the Mayors for the Cities of Gilroy and Morgan Hill alternate serving on this Board. He shared that his other assignments include the Cities Association, the City/School Liaison Committee, and the Silicon Valley Regional Interoperability Advisory (SRVIA). He noted that he recommended Librers for the CalTrain Local Policymaker Group and removed himself from this assignment.

## **B. February 7, 2025 Incident**

### **1. City Manager Christina Turner**

C. Turner advised that she attended the goal-setting workshop on February 7, 2025. She described the purpose of the workshop as for the City Council to discuss its vision and its priorities for the upcoming year. She explained that the workshop is a publicly noticed Council meeting, with one being held in January or February of each year and a mid-year workshop in August.

According to C. Turner, the February 7, 2025 meeting started at 9:00 a.m., and by 9:20 a.m., the Council took a break because the meeting was "so intense." C. Turner explained that Martínez Beltrán wanted the Council to adopt a resolution regarding immigration. She noted that prior to the meeting, Martínez Beltrán requested the resolution be included on the agenda, but Turner declined to include it as part of the agenda for the goal-setting workshop and instead thought the resolution should follow the usual process Council Members followed to have items agendized. C. Turner stated that during the meeting, there was "a lot of back-and-forth" regarding the resolution, with Martínez Beltrán wanting it addressed that day and Turner saying the resolution would be considered as part of the regular process for agendizing items.

C. Turner advised that Turner was seated to her right, while Martínez Beltrán was to her left. According to C. Turner, after Turner called for a break, Martínez Beltrán walked behind C. Turner towards Turner. She stated that she did not see Turner touch Martínez Beltrán but that the video she watched shows Turner

touching Martínez Beltrán on the shoulder. C. Turner reported that she heard Martínez Beltrán say, “Don’t touch me,” using a raised voice. She stated that she did not hear Turner respond, but Turner later told her that he said to Martínez Beltrán, “Hey, you need to calm down.” C. Turner shared that she was still sitting at the time and that both Turner and Martínez Beltrán were standing to her right. She also shared that she did not hear Martínez Beltrán make any other comments to Turner, nor did she hear Turner say to Martínez Beltrán, “You’re going to get in line,” or “Go on, get along.”

C. Turner assumed that based on where Larkin was sitting, he observed the interaction between Martínez Beltrán and Turner.

C. Turner described the room as “tense” after the interaction between Turner and Martínez Beltrán. She stated that after the break, there was no discussion about the interaction, but the meeting continued with an ice-breaker, a discussion of the City’s accomplishments, and public comment. She noted that no one mentioned the incident between Turner and Martínez Beltrán during public comment.

According to C. Turner, after public comment, the City Council discussed their committee assignments, which she described as a “tough” conversation. C. Turner noted that Martínez Beltrán was very distracted after the break and on her phone, and at some point, she left the room and was in the parking lot with her husband.

According to C. Turner, there is no lingering ill will by Turner towards Martínez Beltrán. C. Turner maintained that since the February 7, 2025 incident, Turner has been cordial and professional in his interactions with Martínez Beltrán.

## **2. Council Member Marilyn Librers**

According to Librers, during the February 7, 2025 workshop, Martínez Beltrán was mad that she was not assigned to the City/School Liaison Committee. She stated that during the meeting, Vega stood up for herself and explained why she should be on the committee, while Martínez Beltrán claimed that she had been on the committee for several years and knew the other members of the committee and how the committee works. Librers stated that Martínez Beltrán was also mad that Librers was assigned to the Cities Association as the alternate.

Librers advised that during the February 7, 2025 meeting, she sat next to Martínez Beltrán. She explained that the City Council was seated in a U-shape, with Turner in the middle. According to Librers, during the meeting, Martínez Beltrán would not stop talking, so Turner banged his gavel and politely told Martínez Beltrán that she had her turn. She shared that Martínez Beltrán kept talking, so Turner banged his gavel again and called an unplanned 10-minute break. She noted that she had never seen that happen before during her 11½ years on the City Council. Librers reported that at some point before the break, Martínez Beltrán said to Turner, “You’re retaliating against me because I ran against you for Mayor.”

Librers stated that the Council Members stood up and Martínez Beltrán walked towards Turner. She noted that it was very narrow where they were seated on the floor, and she wondered to herself why Martínez Beltrán did not walk the other way around the tables to get a beverage.

According to Librers, as Martínez Beltrán walked past Turner, he “lightly brushed her hand,” and said to her, using a low volume, “Calm down, [Martínez Beltrán].” She stated that Martínez Beltrán took a few more steps and then yelled, “Don’t touch me.” She shared that Martínez Beltrán again said, “Don’t touch me,” but louder the second time.

Librers opined that Turner tapped Martínez Beltrán on the hand to “try to make peace with her.” She denied seeing Turner grab or hit Martínez Beltrán, and she maintained that Turner barely touched her. She also denied seeing Turner touch Martínez Beltrán’s arm. Librers stated that she did not hear Turner say to Martínez Beltrán, “You’re too much,” “You’re going to get in line,” or “Go on, get along.” She also stated that she did not hear Martínez Beltrán ask Turner, “Did you just push me?” She maintained that even though she was not standing right next to Turner and Martínez Beltrán, she could hear what they said to

each other because she was standing by her seat and Turner was standing by his seat, with only C. Turner's seat between them. She estimated that she was approximately 72 inches from where Turner was standing.

Librers advised that she had not spoken with Martínez Beltrán about the incident that occurred during the February 7, 2025 meeting.

### **3. Council Member Miriam Vega**

Vega advised that Martínez Beltrán arrived late to the February 7, 2025 meeting, and when she arrived, she interrupted whoever was speaking to say that she wanted to discuss "what was going on with immigration." According to Vega, Martínez Beltrán maintained it was urgent and was adamant that it needed to be discussed during that meeting. She stated that Larkin explained to Martínez Beltrán that there is a process to follow for topics to be discussed during Council meetings, and because immigration was not included on the agenda, they could not discuss it. She noted that Larkin and Turner explained to Martínez Beltrán multiple times that it was not possible for them to discuss immigration during that meeting.

Vega reported that the discussion became heated, so Turner struck the gavel and said they would take a 15-minute recess to calm down. Vega noted that she was sitting to the right of Turner.

Vega advised that during the break, she was speaking with Iwanaga and Martínez Beltrán, and C. Turner told them to "break it up" because of the Brown Act, so they explained to C. Turner that they were talking about something personal. According to Vega, while she, Iwanaga, and Martínez Beltrán were talking, Turner tapped Martínez Beltrán from behind her on the left shoulder to get her attention. Vega reported that in response, Martínez Beltrán loudly said, twice, "Get your hands off of me, don't touch me." She shared that Turner "backed off."

Vega maintained that Turner barely tapped Martínez Beltrán to get her attention. She noted that she was standing with her back to the audience, facing the wall, and that C. Turner was standing nearby to the left of her. According to Vega, Iwanaga and Librers were also standing near them.

Vega maintained that she saw Turner come up from behind Martínez Beltrán and tap her on the left shoulder. She stated that she was uncomfortable after hearing Martínez Beltrán scream, so she took a few steps to walk away from the situation.

Vega reported that when the meeting continued, Martínez Beltrán seemed "very distraught" and was on her phone. She shared that at some point, approximately 15 to 20 minutes after the break ended, Martínez Beltrán left the meeting and did not return.

### **4. Council Member Soraida Iwanaga**

Iwanaga stated that she attended the workshop on February 7, 2025, and she opined that as soon as Martínez Beltrán arrived, the mood in the room changed. She explained that she was seated directly across from Martínez Beltrán, and based on Martínez Beltrán's tone and body language, Iwanaga could tell that she was unhappy with Turner because she wanted to discuss something that was not on the agenda, and he would not allow there to be any discussion. She described the meeting as "tense."

According to Iwanaga, before the break, the Council discussed Martínez Beltrán's resolution and committee assignments. She noted that Martínez Beltrán was unhappy that she was not given certain committee assignments, causing the others to feel as if they had to "defend" their assignments.

Iwanaga shared that the Council Members were seated in a U-shape, with her and Vega on one side of the U, and Librers, Martínez Beltrán, the City Clerk, and the Police Chief on the other side, and Turner in the middle of the U. According to Iwanaga, when Turner called for a break, everyone stood up and moved towards the area behind her and Vega, where there was a table of snacks. She explained that she was talking to Vega, but as she did so, she saw Martínez Beltrán walk in Turner's direction and talk to him.

Iwanaga reported that there was a “huge cacophony of ‘get your hands off me’” and “don’t touch me,” and then everyone froze. According to Iwanaga, Turner leaned in to Martínez Beltrán and said to her, “Hey, let’s talk.”

Iwanaga stated that after Martínez Beltrán yelled, she walked towards Iwanaga and Vega, and Iwanaga told her that she needed to calm down because they would discuss her resolution another time.

Iwanaga advised that if Turner touched Martínez Beltrán, it would have been for a millisecond because she saw Martínez Beltrán walk towards him. She stated that she did not see exactly where Turner’s hands were in relation to Martínez Beltrán and did not see any physical contact between them.

Iwanaga shared that Turner has a habit of tapping people on their arm to get their attention, which is what she assumed Turner did because he was leaning towards Martínez Beltrán like he wanted to talk to her. She noted that Libreros and C. Turner were next to or near Turner, and she further noted that it was a very small space to walk past Turner to get to the table with the snacks. She opined that Martínez Beltrán should have gone around the other side of the tables to the food table because there was more room to walk.

Iwanaga denied having any communication with either Martínez Beltrán or Turner about the incident. She acknowledged that she may have asked Turner if he was okay, and she stated that she was concerned for him “knowing the power that women can have,” especially when a woman yells, “Get your hands off of me.”

Iwanaga opined that the situation may have been staged by Martínez Beltrán. She stated that she had a “weird sense” about this, and she shared that Martínez Beltrán arrived at the meeting “on the attack” regarding the committee assignments.

## **5. City Attorney Don Larkin**

Larkin advised that he attended the February 7, 2025 meeting, which he described as the City Council’s annual goal-setting meeting for the upcoming year. Larkin explained that the Council barely got to the adoption of the agenda when Martínez Beltrán said she wanted to add an item to the agenda for a resolution addressing immigration issues related to the Trump administration’s immigration enforcement policies. According to Larkin, there was an approximately 15-minute exchange regarding why they could not add an agenda item because doing so would violate the Brown Act.

Larkin noted that Turner seemed unhappy that the meeting was “hijacked” less than five minutes after it started. He opined it was a little “heated,” especially after the other Council Members expressed that they did not want to discuss anything other than what was on the agenda.

According to Larkin, the agenda was adopted approximately 20 minutes into the meeting, at which point Turner called for a five-minute break to “cool off.” He stated that instead of taking the time to decompress and step away, Martínez Beltrán headed straight for Turner as soon as he called the break. Larkin shared that he assumed Martínez Beltrán was going to talk to him (Larkin), so he stayed in his seat, but then he saw Martínez Beltrán approach Turner and say something to him. Larkin stated that Martínez Beltrán looked angry. He advised that he did not hear what she said, but given that she appeared angry, he stood up and walked towards Turner and Martínez Beltrán to try to defuse the situation. According to Larkin, Martínez Beltrán could have walked around the open part of the tables to avoid interacting with Turner, but instead, Martínez Beltrán walked towards the narrow gap where Turner was standing to confront him. He opined that she walked “pretty deliberately” towards Turner.

Larkin reported hearing Turner say to Martínez Beltrán fairly loudly, “You need to calm down,” or words to this effect, which he opined was the wrong thing for Turner to say to Martínez Beltrán. He noted that Turner has a habit of putting his hands on people to comfort them, or tapping them, which he observed Turner do to Martínez Beltrán. He explained that he observed Turner extend his arm and hand as if he were going to tap Martínez Beltrán on the shoulder, but Larkin did not see Turner actually touch Martínez Beltrán. He stated that he heard Martínez Beltrán say, “Don’t touch me,” or “Take your hands off me,” or words to this effect, and he assumed this was because Turner touched her on her shoulder.



According to Larkin, Martínez Beltrán walked towards him, asking him if he saw what happened. Larkin reported that when Martínez Beltrán asked him if he saw what happened, he replied that he did, not knowing what she thought Larkin saw. He later clarified that he told Martínez Beltrán that he did not see anything but heard her say, "Don't touch me."

Larkin maintained that he did not hear Martínez Beltrán use the word "push," nor did he see anything to indicate that Turner pushed Martínez Beltrán. He explained that if Turner had pushed Martínez Beltrán, he (Larkin) would have seen that. He further maintained that he did not see Turner point his finger at Martínez Beltrán, nor did he hear him say to her, "You're going to get in line."

According to Larkin, Turner has tapped him on the shoulder before, in a reassuring manner. He advised that Turner did that to him all the time, so it did not surprise him to see Turner do it to Martínez Beltrán. He noted that Martínez Beltrán had also tapped him on the shoulder on occasion. Larkin maintained that he was not concerned that Turner touched Martínez Beltrán on the shoulder, but rather, he wished that Turner did not tell Martínez Beltrán to "calm down," as doing so did not help the situation.

Larkin advised that Martínez Beltrán told him that she wanted to make a complaint, so he directed her to Human Resources. He stated that the meeting resumed a short time later and was productive for one or two hours until there was discussion about the committee assignments.

Larkin reported that during a meeting with Martínez Beltrán and Human Resources Director Michael Horta, they let her vent because she was very emotional. He stated that they told Martínez Beltrán that they did not have any authority over Turner because he is an elected official, but they would retain someone to investigate what happened. According to Larkin, during this meeting, Martínez Beltrán mentioned that Turner pushed her, so they recommended to her that she make a police report if she felt she was physically assaulted.

## **6. Council Member/Mayor Mark Turner**

Turner reported that leading up to the meeting on February 7, 2025, he knew that Martínez Beltrán was not happy about the committee assignments. He stated that she also asked him to add an agenda item for a resolution regarding immigration, and that he told her it was not an item to be discussed during the goal-setting workshop, but they could include it on the agenda for the February 19, 2025 City Council meeting. Turner advised that he knew Martínez Beltrán was very upset with him about that as well.

According to Turner, a few minutes into the February 7, 2025 meeting, Martínez Beltrán "took over" and said that it was an emergency situation and that the Council needed to pass a resolution regarding the mass deportations. He noted that Larkin tried to stop Martínez Beltrán from discussing a resolution that was not on the agenda but was unsuccessful in doing so. Turner shared that after 30 minutes of back-and-forth, he called for a five-minute break.

Turner explained that he was seated at the head of the U-shaped arrangement, with C. Turner to his right, and then two Council Members, Martínez Beltrán and Libreros. According to Turner, as he stood up to signal the break, Martínez Beltrán stood up and walked towards him. He noted that he did not know where she was going, but it would have been a clearer path for her to go around the U the other way.

Turner reported that Martínez Beltrán walked up to him, invading his personal space, "jawing" at him, and "carrying on very aggressively." He stated that he said to her, "Hey, you've got to calm down." According to Turner, his hands were "in the air moving" because he talks with his hands, and his hand brushed against Martínez Beltrán's wrist. Turner shared that Martínez Beltrán immediately started screaming, "Don't touch me, don't touch me." Turner said he replied, "Whatever," and walked away. He shared that he wondered to himself if Martínez Beltrán designed the incident to make him look bad.

Turner stated that immediately after the break, the Council discussed committee assignments. He noted that Martínez Beltrán was very engaged in this discussion, and he described her as "critical, aggressive, combative, and bullying" towards the other Council Members. He stated that she had a number of supporters present who spoke about how wonderful she is and how much experience she has. Turner

shared that Martínez Beltrán “demanded” all of her assignments back, so Turner explained to her that it was the City Council’s decision and that the recommendations were already made. According to Turner, a vote approving his recommended assignments passed four-to-one.

Turner advised that after the lunch break, Martínez Beltrán “just sat and sulked, sent emails,” and eventually left the meeting.

Turner shared that he watched a video of the exchange between himself and Martínez Beltrán. He noted that there was no audio but that the video shows Martínez Beltrán walk past him and a verbal exchange occur between them. However, he stated, there is no indication that Turner pushed Martínez Beltrán, and that the only one who appeared to be yelling was Martínez Beltrán.

According to Turner, Iwanaga and Librers saw the entire exchange.

Turner shared that Martínez Beltrán tends to have disruptive relationships with the other Council Members. He stated that prior to the 2024 election, Librers told him that Martínez Beltrán said to her that she and Turner are “too old and too White to be on this Council.” He also reported that Hispanic women who supported him during the election said that Martínez Beltrán questioned why they supported Turner because he is not “one of us.”<sup>17</sup>

Turner advised that shortly after the event, he spoke to both Librers and Iwanaga about what they observed, and they were in “total shock.” He noted that others observed Martínez Beltrán to be very aggressive and combative with him, but on February 7, 2025, reported that she took on the whole City Council.

## **VI. FINDINGS OF FACT**

The purpose of this report is to make findings of fact on the allegations of misconduct made against Turner. This report does not express any opinion as to whether any of the actions described herein rise to the level of a violation of City policies or State law.

In conducting this investigation, the undersigned did not set out to prove or disprove the allegations, but rather to gather information in a neutral fashion and reach reasoned conclusions. The City gave the undersigned the discretion to conduct this investigation without interference and did not attempt to influence the findings in this report. The factual findings were made by carefully analyzing the documentary and testimonial evidence gathered as part of the investigation.<sup>18</sup>

### **A. Credibility Assessment**

It is important to note that prior to making a determination regarding the facts as alleged, the credibility of each witness was considered. In evaluating a witness’s credibility, many factors were considered, including possible bias or motivation to lie, the ability of a witness to recall information, the specificity of the information provided, whether the information provided was consistent with prior statements made by the witness and/or statements made by other witnesses, and the inherent plausibility of the information provided.

There is reason to question the reliability of what several of the witnesses reported. Specifically, both Martínez Beltrán and Turner have questionable credibility due to their motivation to downplay their conduct on February 7, 2025, to avoid public disapproval. Additionally, Martínez Beltrán is potentially motivated to falsely attribute conduct to Turner because she is upset that she lost the election for Mayor to him, while he is potentially motivated to seek retribution against Martínez Beltrán for running against him. Additionally, Martínez Beltrán was visibly upset with Turner during the February 7, 2025 meeting when he would not allow her to discuss her proposed resolution, which could also motivate her to make

false allegations against him, or exaggerate what occurred between them, in order to make him look bad to those present in the room and his constituents.

Although there is no reason to believe that C. Turner, Larkin, and the other Council Members intentionally misrepresented what they observed, the reliability of some of the information they provided is questionable because what they reported is inconsistent with what is depicted on the video provided by C. Turner.<sup>19</sup> More likely than not, discrepancies in their statements stem from varying perceptions and recollections of the specific incidents that are within the scope of this investigation, and the passage of time.

Specifically, the video depicts that both C. Turner and Librers remained seated when Martínez Beltrán stood up and walked towards where Turner was standing. Martínez Beltrán incorrectly reported that C. Turner was standing when the incident between her and Turner occurred. The video also depicts Turner lift his right arm slightly and appear to touch Martínez Beltrán's left forearm, and not her shoulder, as reported by C. Turner and Vega. The video then shows Turner put his arm down and continue interacting with Martínez Beltrán for a couple of seconds. At no time does the video depict Turner pointing at Martínez Beltrán.

Several of the witnesses appear to conflate different breaks or conversations that occurred during the February 7, 2025 meeting. For example, Vega reported that just prior to the incident between Martínez Beltrán and Turner, she and Iwanaga were talking to Martínez Beltrán, and C. Turner approached them to caution them about the Brown Act. However, the video shows that C. Turner remained seated during the incident between Martínez Beltrán and Turner, and that the interaction occurred within seconds of Martínez Beltrán standing up and walking towards the other side of the room before she got near where Vega and Iwanaga were seated and/or standing.

The video of the full meeting posted on the City's website has a "filler screen" during the break, so there is no public video of the interaction between Martínez Beltrán and Turner. What this video shows is that at approximately 18 minutes into the meeting, Turner called for a five-minute break. Prior to the break, the only discussion involved the immigration resolution Martínez Beltrán wanted to adopt. There was no discussion about the committee assignments prior to the break. In fact, this discussion did not occur until approximately 80 minutes after the meeting began.

Further undermining Martínez Beltrán's credibility is that her description of what occurred during her interview with the undersigned is inconsistent with what she reported to the police.<sup>20</sup> Notably, in the police report, the responding Police Officer wrote that when Martínez Beltrán reenacted what occurred between her and Turner, she used her right hand with fingers extended to push her husband's stomach, causing him to move backwards.<sup>21</sup> According to the police report, Martínez Beltrán confirmed to the Police Officer that she was pushed in the stomach and that the push caused her to move backwards. During her interview with the undersigned, Martínez Beltrán denied that Turner touched her stomach.

Based upon the foregoing, when analyzing the evidence presented to make the following findings, the undersigned relied primarily on the video she was provided, and not the inconsistent descriptions of what occurred.

## **B. Findings Of Fact**

### **1. Committee Assignments**

The credible evidence fails to establish by a preponderance of the evidence that Turner recommended removing Martínez Beltrán from committee assignments or recommended that she not be assigned to committee assignments based on her race, gender, and/or because she ran against him for Mayor. Rather, it is more likely than not that Turner's recommendations were based upon what he perceived to be a fair and equitable distribution of assignments.

Martínez Beltrán's claim that she was somehow mistreated by Turner based on his recommendations is undermined by the fact that she was given the opportunity to provide C. Turner with a list of her preferred committee assignments but failed to do so. Whereas Librers, Vega, and Iwanaga responded to C. Turner's email asking the Council Members to identify the committees they wanted to be assigned to, Martínez Beltrán did not respond.

Further, Turner and the other Council Members provided a legitimate explanation for why Turner's recommendations made sense. For example, Vega is a school teacher and is the only school teacher on the City Council, and it is logical for her to serve as the City/School Liaison Committee. Additionally, Turner's explanation that he wanted continuity on the Cities Association Committee is reasonable in light of the fact that the Librers wanted the assignment and had served in the same role the year prior, and that there is no rule proscribing that the Mayor Pro Tem serve as the alternate. The fact that past practice was to appoint the Mayor Pro Tem as the alternate to the Cities Association Committee does not require Turner to continue with past practice.

Finally, Martínez Beltrán claims that she was removed from multiple committee assignments, evidencing that Turner has animus against her. What she fails to recognize is that the City Council has five members, two of whom were new to the City Council and expressed an interest in serving on committees. The chart of assignments included on the City's website shows that Martínez Beltrán is the primary Council Member assigned to seven committees, while Librers, Vega, and Iwanaga are assigned to fewer committees than Martínez Beltrán.<sup>22</sup> These numbers undermine Martínez Beltrán's claim that she was subjected to disparate treatment compared to her colleagues on the City Council, or that Turner harbored any animus against her based on her race, gender, and/or the fact that she ran against him for Mayor.

### **2. February 7, 2025 Incident**

Martínez Beltrán's claim that during the February 7, 2025, meeting, Turner pushed her is not corroborated by the credible evidence presented, specifically the 20-second video provided to the undersigned. Additionally, none of the witnesses interviewed observed Turner push Martínez Beltrán.

It is undisputed that during the February 7, 2025 City Council goal-setting meeting, during a break, Turner touched Martínez Beltrán. Turner admitted to engaging in this conduct, and the video confirms there was some sort of contact between them. What Turner credibly denied doing, and what is not depicted on the video, was pushing Martínez Beltrán. The video also does not show Turner yelling at Martínez Beltrán or "scolding her like a child," as she reported to the police. Further, the video does not depict Turner pointing his finger at Martínez Beltrán.

Whereas Martínez Beltrán claims that Turner pushed her and that she said to him, "Don't push me," all of the witnesses who were present and observed the interaction between Turner and Martínez Beltrán reported hearing Martínez Beltrán use the word "touch" and not the word "push." This is significant because Turner was described by Larkin and others as someone who "talks with his hands," and therefore, he touches people when speaking to them. Martínez Beltrán's use of the word "push" implied that Turner's contact with her was aggressive or violent, which is much different from a "touch."

It is also undisputed that Turner told Martínez Beltrán to “calm down.” Turner admitted making a comment to this effect, and Larkin and Librers corroborated hearing this comment.

Turner reported during his interview that he recommended Martínez Beltrán be appointed Mayor Pro Tem, which was ratified by the other Council Members. Although he could have recommended any Council Member to serve as Mayor Pro Tem, he credibly explained that he did not think it was appropriate for Vega and Iwanaga to serve in this role given they are brand new to the City Council. Turner could have recommended Librers serve another term as Mayor Pro Tem, but he did not do so, undermining Martínez Beltrán’s claim that Turner harbors any animus against her for running against him for Mayor.

The undersigned relied primarily on the video provided by C. Turner because it provides the most reliable and objective information regarding the interaction at issue. Moreover, as noted above, there were a number of factual discrepancies between what all of the witnesses reported. Significantly, the video footage shows Martínez Beltrán walking towards where Turner was standing, instead of walking around the tables on the other side to avoid interacting with him. The video also shows Martínez Beltrán putting up her arms as she nears Turner, and him sticking out his right arm, which appears to come into contact with Martínez Beltrán’s right arm. The video indicates that Turner continues to engage with someone who is off screen, presumably Martínez Beltrán, for approximately five seconds before he returns to his seat and sits down. What the video does not depict is Turner yelling or pointing at Martínez Beltrán as she approaches him, which directly contradicts what she alleged.

### **VII. CONCLUSION**

Based upon the foregoing, the allegations against Turner are not sustained. The credible evidence presented fails to establish by a preponderance of the evidence that Turner was improperly motivated by Martínez Beltrán’s race, gender, and/or her running against him for Mayor when he did not recommend Martínez Beltrán for the committee assignments she wanted or when he touched her arm during the February 7, 2025 Council meeting. Similarly, the credible evidence presented does not show by a preponderance of the evidence that Turner yelled at, pointed at, and pushed Martínez Beltrán, or otherwise engaged in any aggressive conduct towards her during the February 7, 2025 Council meeting.

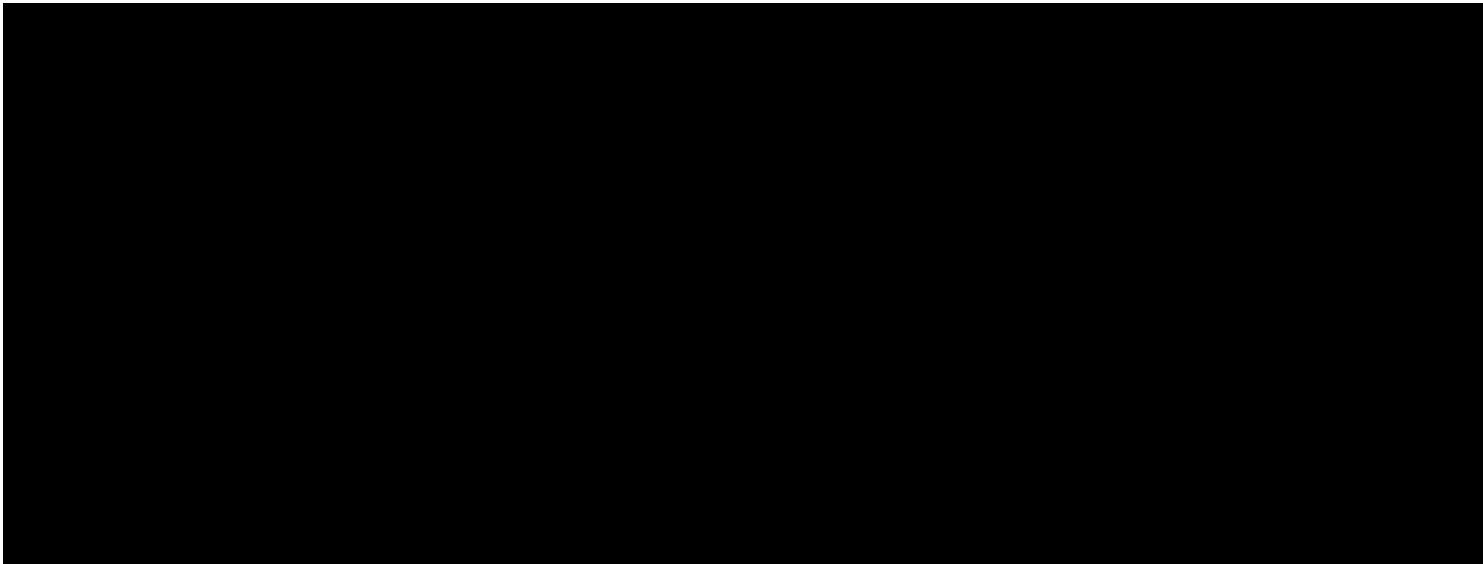

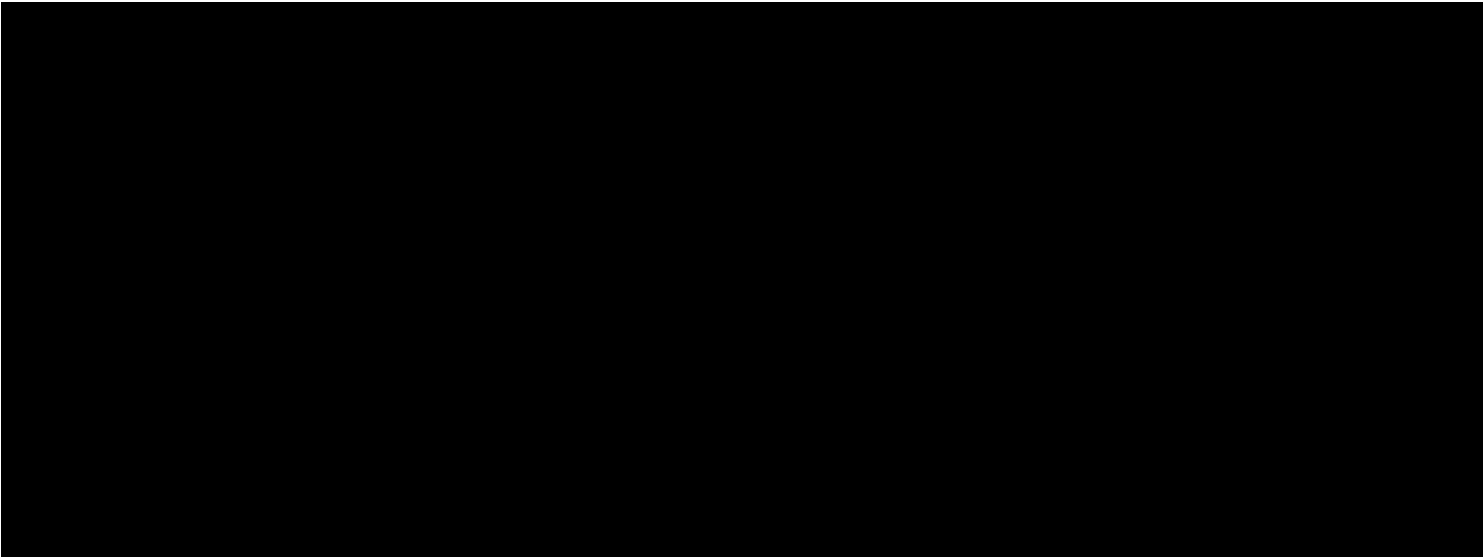

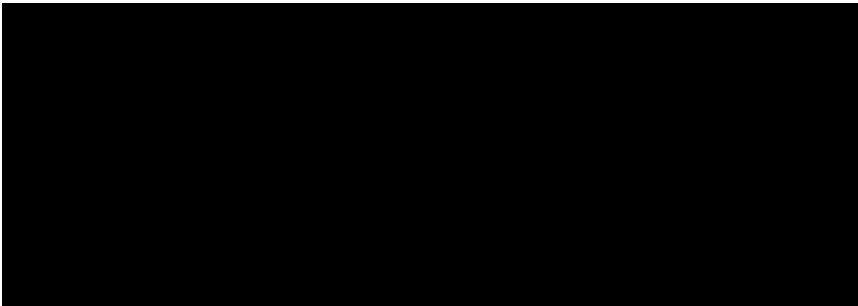

### NARRATIVE:

On 02/07/2025, at approximately 1550 hours, I was dispatched to the Morgan Hill Police Department lobby at 16200 Vineyard Blvd in the City of Morgan Hill for the report of prior battery. The battery had occurred during a city council meeting in the council chambers located at 17555 Peak Ave. I arrived in the lobby and met with City of Morgan Hill Council Member Yvonne [REDACTED] and her husband.

Yvonne provided the following statement.

### STATEMENTS OF YVONNE:

On 02/07/2025, at approximately 0930 hours, there was a council workshop at the council chambers. The discussion was heated, and the mayor (Mark [REDACTED]) was not happy about it. The floor was setup with chairs in a semi-circle and was an information meeting that was recorded.

Yvonne had proposed a resolution which revolved around immigration, which the mayor had told her prior not to put it in the workshop. Yvonne had researched policies with the attorney, that she wanted to explore but the mayor told her she could not speak. The mayor got frustrated and ended the meeting for a break.

Yvonne got up from her chair and walked over to get something to drink. Yvonne and the mayor passed by each other and Yvonne was shaking her head while the mayor was yelling and scolding her (like she is his daughter) while pointing in her face. The mayor told her she was too much and to get in line.

The mayor then pushed Yvonne. When Yvonne was explaining that she was pushed by the mayor, she re-enacted it on her husband. I asked Yvonne if that is how she was pushed and she showed me again, but it was different than the first time.

I asked Yvonne if her and her husband would act out the incident and show me how she was pushed.

Yvonne was pointing with her finger up in the air as if she was the mayor and as if her husband was her. Yvonne stated the mayor was yelling her, "You're not gonna this.." Yvonne responded, "You're too much" with her hands out to her sides. The mayor then pointed at her and said, "You're going to get in line." Yvonne then demonstrated a shove where her right hand and fingers were extended and pushed into her husband's stomach causing him to move backwards. I clarified if Yvonne had been pushed to where she also had been pushed backwards, which she responded, "Yeah."

I later asked Yvonne if she had felt any pain from the push. I gave Yvonne a scale from 0 to 10, where 0 pain is no pain and 10 pain is the worst pain she had ever felt. Yvonne told me she felt a 2 to 3 out of 10 pain, when she was pushed and shocked that it had occurred. Yvonne declined any medical attention.

Yvonne asked the mayor, "Did you just put your hands on me? Don't touch me." The mayor responded along the lines of, "Get along, or go on." Yvonne stated, "Oh my God, I cannot believe you put your hands on me." Yvonne turned and told the City Attorney, Donald Larkin, that the mayor had just pushed her.

Yvonne then spoke with the city attorney about what she should do and then later went to the Morgan Hill Human Resources Department and spoke with the HR manager Michael [REDACTED] about the incident.

Yvonne then returned to the council chambers to continue the meeting and was shaken and could not believe what had happened. Yvonne was upset and the meeting continued, and no further altercations occurred.

Yvonne did not notice if anyone had witnessed the incident but told me the city council and public were present. Yvonne believed no one came forward to do something or say something because he is the mayor.

I explained the process for a citizen's arrest for a misdemeanor. Yvonne desired criminal prosecution against the mayor for the battery.

Yvonne then went on to ask about how to obtain a prior reported incident. I referred her to the MHPD Records Division for a copy of the report. I answered additional questions not related to this incident and Yvonne provided no further statements regarding the battery.

Based upon Yvonne's statements and interaction with the City Attorney, Donald [REDACTED] I contacted him for an interview. I met with Donald at 17555 Peak Ave in his office and he provided the following statement.

### STATEMENTS OF DONALD:

Donald was in the meeting in the council chambers. I asked Donald what had happened. Donald explained there was a heated discussion about a resolution on immigration. The meeting became heated between council member Martinez and the mayor. The mayor called for a five-minute break.

Yvonne stood up and began to walk around the seating area, Donald believed she was coming to talk to him because of an earlier discussion. Donald noticed Yvonne walk towards the mayor where there was a small gap to get around him, which he approximated to be 3ft. As opposed to walking around the larger opening towards the public.

Donald heard Yvonne say something to the mayor but could not make out what she had said. Donald was headed to talk to Yvonne when he heard the mayor say fairly loudly, something like, "You need to calm down."

Donald then went on to explain the mayor's habit of placing his hand on their shoulder. Donald saw what looked like the mayor was about to put his hand on her shoulder and heard Yvonne yell "Don't put your hands on me."

Donald believed the mayor had reached out with his left hand. Donald did not see his right hand or notice his right hand doing anything. Yvonne then continued by the mayor and met with Donald to make a personnel complaint. Donald explained the process to Yvonne about the internal city procedure.

I asked Donald if anyone else had witnessed the incident and he was not sure, and no one said anything to him. I asked if Yvonne had complained about any pain or if he had seen the mayor strike her or she had struck him. Donald went on to state the altercation did not look physical to him and that it was a habit of the mayor to touch people's shoulder and that is what it looked like to him. Donald did not see any pushing or act of pushing and if he had he would have reported it to police. Donald stated the interaction between Mark and Yvonne was probably a couple of feet from each other and not quite face to face.

The city manager, Christina [REDACTED] opened Donald's office door for another officer that had just arrived to assist. I asked Christina if she was present during the meeting which she stated she was. I met with Christina in her office next door, and she provided the following statement.

### STATEMENTS OF CHRISTINA:

Christina stated the meeting had begun at 0900hours and began to explain who was present at the meeting which included, five council members, the mayor and the leadership team. During the meeting Yvonne wanted to move forward with a discussion for action and the council did not want to go in that direction. The meeting became tense, and the mayor stated they were going to take a 5-minute break. Christina explained where Yvonne was sitting in comparison to Mark and saw Yvonne get up and go towards where Mark was at and heard Mark say to Yvonne, "You need to calm down." Christina then heard Yvonne say, "Don't touch me."

Christina did not see any physical altercation occur between Mark or Yvonne. I asked Christina if there was possibly anyone else that had witnessed the altercation. Christina told me council members Soraida and Miriam had possibly witnessed the incident.

Christina provided me with information on how to obtain the video recording of the meeting and the contact information for both council members. I called Soraida [REDACTED] and arranged to meet with her at the corner of Monterey Rd and W 3rd St next to Ladera Grill where she was located. I met with Soraida, and she provided me the following statement.

### STATEMENTS OF SORAIDA:

I met with Soraida and asked her what had happened during the meeting. Soraida stated the only thing that she had seen was Yvonne walking towards the mayor and she was already upset. The mayor reached out gently and lightly touched Yvonne on her left wrist. Soraida explained the touch was as if it meant to say, "I wanna talk to you."

Soraida again explained Yvonne was already emotional and very upset because she was wanting to make a resolution about immigration which caused tension.

Soraida heard the mayor tell Yvonne, "Let's talk about this" and saw him reaching out to her with his right hand.

Soraida did not see any physical altercation or push occur. Soraida again stated that all that happened was the mayor reached out with his hand to get her attention. Soraida heard Yvonne stated, "Don't touch me, don't touch me."

The council took a 5-minute break, and the session returned, and Yvonne was on her phone the afterwards texting.

Following my interview with Soraida a city employee, Michelle [REDACTED] with access to the video surveillance told me another city employee, Sergio [REDACTED] would come by at a later time and provide me with video footage.

### NARRATIVE CONTINUED:

On 02/08/2025, I continued my investigation into the alleged incident that had occurred. I called Mayor Mark [REDACTED] and arranged an interview at the MHPD. The mayor arrived at the MHPD and wanted to provide a statement in the interview adjacent to the lobby.

I told the mayor I was conducting an investigation into an alleged incident during the council meeting day prior. I told the mayor he was not under arrest or being detained and was free to leave at any point through the unlocked door adjacent to me and back out the main entrance into the police department lobby. The mayor provided the following statement.

### STATEMENTS OF MARK:

I told Mark I was investigating an incident that occurred around 0930 hours and asked him what had happened. Mark stated there was a contentious conversation. Mark called for a 5-minute break and stood up. Yvonne began to walk towards him which he assumed she was going to make her way to the other side of the room, and she was "chirping" something.

Mark demonstrated how the interaction occurred and while he was doing so I noticed Mark talked a lot with hand movement.

Yvonne towards him and as he turned towards her, he put the back of his hand with his fingers on her wrist and said, "Hey, you gotta settle down." Mark explained that was it and she said, "Don't touch me, don't touch me." Mark explained that she was saying that in a very raised voice. Mark said he reached out and touched her with his right hand on her left wrist.

After she made those statements, Mark told her she needed to go on her way, and she just walked away. Mark explained that nothing else occurred afterwards and the meeting continued after the 5-minute break.

Mark explained that nothing happened prior to the meeting or after the meeting and that Marilyn [REDACTED] and Soraida [REDACTED] had witnessed it. Mark provided me with both of their contact information.

Mark further explained that there was no physical altercation and that there had been no prior incidents of physical altercations or threats between either of them.

### STATEMENTS OF MARILYN:

I called Council Member Marilyn and arranged an interview at the MHPD. Marilyn arrived and met with me in the interview room. I told Marilyn I was investigating an alleged incident that had occurred at the city council chambers meeting at around 0930 hours. Marilyn knew what I was referring to and provided the following statement.

Marilyn knew I was talking about the mayor and Yvonne. There had been a heated discussion by Yvonne and she was not getting what she wanted during the meeting. The mayor called for a 5-minute break, banged the gavel and stood up. Marilyn watched her get up and walk towards the mayor and wondered why she would walk past the mayor after the altercation had occurred and that it was a narrow pathway in that direction opposed to going the other direction to get to the other side.

Yvonne got up and walked by the city manager, the mayor reached with his right hand and very kindly told Yvonne to calm down and touched her hand. The mayor did not grab her just touched her hand and provided her comforting words. Marilyn did not see the mayor do anything with his left hand.

Marilyn stated she watched the whole thing. Yvonne then screamed "Don't touch me. Don't touch me." and she jumped back like someone had grabbed her. Yvonne then proceeded to keep walking. Marilyn saw everyone leave for the break and Yvonne went outside.

Marilyn stated she had a clear view of the interaction and that no other physical contact occurred, which she further expanded on as manhandling, grabbing her arm, touching her shoulder, her back, or any other part of her body, other than her hand and just said, calm down. Marilyn explained that Yvonne had just went berserk.

Marilyn reiterated what had happened and explained how the discussion about immigration had let up to her temper flaring. The tension revolved around the issues she had brought up and there was no other altercation before the meeting.

### NARRATIVE CONTINUED:

I was provided with video recording from Sergio [REDACTED]. The video surveillance was approximately 3 hours in length. Due to the size of the video recording, I was unable to upload it to Axon's evidence.com directly and I transferred the video onto a USB drive. I later packaged and submitted the digital recording on the USB drive into evidence at the MHPD.

I reviewed the video recording of the meeting and interaction between the Mark and Yvonne. The following is a brief synopsis of that interaction. I did not watch the entirety of the meeting or complete events leading up to the 5-minute break period. Refer to the recording on the USB drive for complete details.

### SUMMARY OF VIDEO SURVEILLANCE:

At around 17:40 minutes into the recording tensions had risen and the mayor called for a 5-minute recess. Yvonne can be heard trying to interject and going back and forth with the mayor. The mayor breaks the meeting and stands up and walked to his right. Yvonne stands up and walks towards where the mayor is located and prior to being face to face she puts her hands up at shoulder height while he leaned in towards her as if he was saying something. The mayor can be seen lightly touching Yvonne with his right hand on her left wrist as she continued by him. The two go off to the side of the screen and only Mark is visible.

Mark's elbows are tight next to his waist and then he placed his right hand into his pocket and his left hand can be seen down at his side. Shortly after he spun around and went back to sit in his seat.

At no time during the video recording was there any obvious signs of a push or physical altercation.

At the time of completing this report I was unable to determine if a battery had occurred and I am requesting the District Attorney Review this report to determine if a crime had occurred.

The additional potential witnesses I plan to interview are Michael [REDACTED] Nick [REDACTED] and Council Member Miram [REDACTED] and add their statements if they witnessed the incident.

### ACTIVITY:

On 02/12/2025, at approximately 1030 hours, I contacted Nick [REDACTED] (City of Morgan Hill Chief Operating Officer) via my department issued cellphone. Nick was present at the meeting but did not witness the incident occur and only heard a commotion during the 0930 break that took place on 02/07/2025.

At approximately 1040 hours, I contacted Miriam [REDACTED] (City Council Member) via my department issued cellphone. Miriam was present during the meeting, seated next to Soraida, and was on her cellphone during the 5-minute break. Miriam heard Yvonne scream, "Don't touch me, don't touch me!" Miriam looked up and saw mark reach out with his left hand as if he was going to pat Yvonne on her shoulder. Miriam did not witness any other physical altercation and felt embarrassed regarding the incident.

At approximately 1050 hours, I contacted Michael [REDACTED] (Human Resources Director) via my department issued cellphone. Michael was present at the meeting but did not witness the incident but was put on notice by Yvonne about the mayor making physical contact with her. Michael and Yvonne had a confidential meeting regarding the incident, and he was unable to provide me the details.

As of the submission of this report, there have been no additional witnesses that have come forward, and no additional evidence has been provided for this incident.
